## What data do we collect?

Our Company collects the following data:

- Personal identification information (Name, email address, phone number, etc.)
- Submitted documents and information

## How do we collect your data?

You directly provide Our Company with most of the data we collect. We collect data and process data when you:

- Voluntarily submit a contact form or survey response to us in order to submit your information for investment consideration and / or for award consideration
- Voluntarily complete a survey or provide feedback on any of our message boards or via email.
- Voluntarily submit information to us via any digital or oral means
- Use or view our website via your browser’s cookies

Our Company may also receive your data indirectly from the following sources:

- Publicly available information, sources, websites, etc.

## How will we use your data?

Our Company collects your data so that we can:

- Process your request to review your submission
- Develop understanding of industry trends
- Contact you with feedback
- Contact you with relevant opportunities

When Our Company processes your request, it may send your data to, and also use the resulting information from, credit reference agencies to prevent fraud.

## How do we store your data?

Our Company securely stores your data via HubSpot and [HubSpot's EU-based data centre](#), via Microsoft Business 365 within their [EU Data Boundary](#), via [Google Cloud](#), and via [SeaTable's European-based data centres](#).

Our Company will keep your personal data and venture data for 15 years after your last contact with us. Once this time period has expired, we will delete your data via HubSpot's GDPR compliant deletion of data, Microsoft's Cloud App Security, and manual deletion on Google and SeaTable.

## What are your data protection rights?

Our Company would like to make sure you are fully aware of all of your data protection rights

Every user is entitled to the following:

- The right to access - You have the right to request Our Company for copies of your personal data. We may charge you a small fee for this service.
- The right to rectification - You have the right to request that Our Company correct any information you believe is inaccurate. You also have the right to request Our Company to complete information you believe is incomplete.
- The right to erasure - You have the right to request that Our Company erase your personal data, under certain conditions.
- The right to restrict processing - You have the right to request that Our Company restrict the processing of your personal data, under certain conditions.
- The right to object to processing - You have the right to object to Our Company's processing of your personal data, under certain conditions.
- The right to data portability - You have the right to request that Our Company transfer the data that we have collected to another organization, or directly to you, under certain conditions.
